Hi Everyone:

I received the email below from Greg Clifton this afternoon.

The Ride festival has secured Pearl Jam for their event, a two day festival occurring July 9th and 10th. They are requesting that Telluride increase the number of tickets they may sell from 9,000 to 11,500. This increase necessitates additional parking which would mean we would need to allow them to overflow out of GPG and onto our streets. Unfortunately, the Ride needs to know that they have our approval for this prior to March 4th as they are contractually obligated to begin ticket sales on March 4th. If they cannot have 11,500 ticket sales they need to adjust the price of the tickets upward.

We have our RTA meeting on Monday 2/22 and I believe all Council members are attending except for you. **Would you** be available for a special meeting beginning at 8:30 on Monday, February 22nd prior to our RTA Meeting? Please R.S.V.P. as soon as possible so we can prepare and post notice of the meeting.

I believe Dan Jansen will not be in attendance so Marty will be acting Mayor Pro-Tem.

Pearl Jam is coming to the 2016 Ride Festival, second weekend in July (9th &10th). Because of the big headliner band, the promoter is requesting that the event to be increased to a capacity of 11,500 which will trigger a barricade upon the Telluride Spur, among other things. The Town of Telluride will reach its capacity on internal parking and will need to see additional parking elsewhere to accommodate the increased crowds.

The applicant, Todd Creel, will be submitting a formal request for increased parking in Mountain Village to match what occurs during the annual Bluegrass Festival which handles the same crowd size (11,500). This necessitates on-street parking.

Because of the very short turnaround in the review process (there is a required short window of time between announcement of the event and ticket sales), this matter was disclosed and discussed for the first time at our Council meeting yesterday. We will need to have the matter brought back to the Telluride Town Council by special meeting on March 4th. Today it was addressed by the Telluride Parks and Rec Commission. The outcome of that meeting was forwarded to you by Stephanie moments ago (they recommended approval).

I am writing this email to simply explain the expedited review process and ask that MV consider this additional parking request in an abbreviated time frame as I understand your Council will not be meeting again until mid-March. We would respectfully request a consideration of this request prior to March 4th. Is this doable?

We are excited about this show which will bring a lot of visitors and revenue to both communities. We request that the MV Town Council consider the parking request as one of the many instances where we share resources to effectuate a common benefit. Thank you for the consideration ... especially under the inconvenient circumstances.

THE RIDE FESTIVAL 2016 ECONOMIC IMPACT ESTIMATES

CONSIDERATIONS

In terms of roomnights, calculations assume 100% of camping will be used and "comp'd" and "friends and family" attendees will stay in non-hotbed lodging.

In terms of "hotbed" usage, the calculations are the two-year average ADR at Festival 1 rates.

▶ In terms of daily F&B/retail spend, calculations account for: campers: \$25 per person per day (PPPD); hotbed visitors: \$65 (PPPD); comp'd visitors: \$75 (PPPD).

▶ The "total economic impact" multiplier is 2.75, which is conservative but, appropriate given the size of our community.

CONCLUSIONS

Given previous years' occupancy levels, ADR is anticipated to be double monthly average and region's occupancy level will be 95% to "Sold-Out"

► Given the anticipated demographic, we anticipate hotbeds to be sold first and camping to follow.

► Total direct economic impact is estimated to be \$5.6 million - with a 2.75 economic multiplier, estimated total economic impact is \$13.8+ million
